You are cordially invited to join the Federal Insurance & Mitigation Administration and the NFIP Bureau & Statistical Agent in a 2 1/2 day master's course on the National Flood Insurance Program on **November 12 - 14, 2001**, at the GreenTec IV Auditorium, in Lanham, Maryland.

Through the use of small group exercises, team assignments, case studies, and instructor-led discussions, this year's conference will focus on enhancing your store of NFIP knowledge. The conference is designed to benefit anyone who has responsibility for conducting NFIP training, providing technical assistance regarding the rules and regulations of the Program, or possessing an in-depth understanding of the NFIP rules and regulations in conjunction with their daily work activities. Company trainers, underwriting managers, customer service managers, and Principal Coordinators are encouraged to attend.

- Application and rating both basic and advanced

The BTC will be held at GreenTec IV Auditorium, 7700 Hubble Drive, Lanham, MD 20706.
