Effective October 1, 2002, the Cash Management Procedures will require WYO companies to submit excess funds exceeding \$100,000 via wire transfer. In addition, the e-business initiative allowing customers to make flood insurance premium payments with paperless check transactions using the internet will commence on October 1, 2002. This memo provides samples of the revised exhibits that must be used to report these transactions.

- The wire transfer payments must be reported on Exhibit VIII-E, Wire Transfers to NFIP. Line 805E represents the funds remitted to the U.S. Treasury through the use of the wire transfer mechanism. The total is then brought forward to Exhibit VIII-B, Line 805-E. Each wire transfer must be reported on the day that it is made.
- The internet transactions must be reported on Exhibit VIII-D, Internet Payments to NFIP. Line 805-D represents the funds collected through the internet system. The total is then brought forward to Exhibit VIII-B, Line 805-D. Each internet transfer must be reported on the day that it is made.
