Claims Review - Hurricane Claude **SUBJECT:** 

Hurricane Claudette made landfall at Port Lavaca, Texas, as a Category I hurricane with sustained winds at 88 mph on July 14, 2003. This minimal hurricane caused moderate flood damage to residential and commercial properties in several counties. There may be occurrences of a wind and flood policy at the same property address. In these instances a flood claim should not be opened unless there is evidence that the property sustained direct physical loss by or from flood.

The Single Adjuster Program has not been activated in Texas. In order to avoid numerous reported claims that will be closed without payment, carefully review all claims prior to assignment to the adjuster. Claims should not be assigned simply because the property is insured against wind and flood.

The NFIP Bureau and Statistical Agent will monitor claims that have been statistically reported as "Closed Without Payment" (CWOP).
