SUBJECT: October 1, 2007, Program Changes -

Data Integrity Enforcement Upgrade

The purpose of this memorandum is to provide notification of the changes that are to be implemented effective October 1, 2007, in support of the NextGen Project. Our goal is to ensure that statistical submissions for required data elements comply with longstanding Transaction Record Reporting and Processing (TRRP) Plan formatting specifications. For example, data elements required to be submitted as numeric will now reject if non-numeric information is submitted.

The attached pages indicate selected TRRP errors that will begin processing at the NFIP Bureau & Statistical Agent (NFIP B&SA) as TRRP rejects with the October 2007 cycle in November 2007. There should be no impact for companies that already enforce their data entry to the required specifications.

As part of the transition, the new logic will be applied to all transactions that have a policy effective date on or after October 1, 2007. To assist you with easily identifying the "new rejected transaction," the error message will remain the same as it currently appears in the Edit Specifications Manual. However, the "new rejected transactions" will be included in the reject data files and reports in lieu of the error data files and reports.

Immediate attention will be required for "new reject transactions," especially those associated with money because of their impact on our financial variances. Swift resolution is also needed because claims transactions will not process statistically at the NFIP B&SA if the policy effective date is on or after October 1, 2007, but has unresolved "new reject transactions."

Any policy with an effective date prior to October 1, 2007, will not be impacted at this time. In addition, any transactions submitted against policies with an effective date prior to October 1, 2007, will continue to process statistically at the NFIP B&SA with the current logic.

Please note that policies with an effective date prior to October 1, 2007, which previously received any of the selected TRRP errors will not be stripped, and will continue to appear on the error reports and data files. Therefore, in some instances, policies will have the same TRRP error codes on both the reject and error files.

Updated October 1, 2007, pages for the TRRP Plan and the Edit Specifications Manual will not be done at this time, but will be incorporated in future revisions.
