SUBJECT: May 2008 TRRP Plan Updates (Change 12) and

Edit Specifications Updates (Change 5)

The purpose of this memorandum is to provide notification of further changes and clarifications to the NFIP Transaction Record Reporting and Processing (TRRP) Plan and the WYO Edit Specifications, effective May 1, 2008, as described below:

- Explained criteria governing eligibility/ineligibility of policies effective on or after May 1, 2008, for the Community Rating System (CRS) Classification Credit Percentage.
- Decreased the field length for new data element 'Case File Number for Disaster Assistance' from 15 characters to 9 characters (alphanumeric) and relocated the data element on the TRRP record.
- Renamed data element 'Basement/Enclosure Type' to 'Basement/Enclosure/Crawlspace Type'.
- Effective May 1, 2008, condominium indicator 'A' is now allowed for Preferred Risk Policies only if the condominium association is ineligible for the RCBAP.
- Created two new Obstruction Types: '70' (With Certification subgrade crawlspace) and '80' (Without Certification subgrade crawlspace). Buildings with subgrade crawlspaces are eligible for the community's CRS discount provided that they have a letter from a community official certifying that the subgrade crawlspace is built in compliance with the NFIP requirements for crawlspace construction, as outlined in FEMA Technical Bulletin 11-01, Crawlspace Construction for Buildings Located in Special Flood Hazard Areas, available online at http://www.fema.gov/pdf/fima/tb1101.pdf.

• New Risk Rating Method 'S' (FEMA Special Rates) can be reported on policies effective on or after May 1, 2008.

Because of the late date relative to the May 1, 2008, changes and clarifications, the WYO companies are not expected to complete these reporting modifications by May 1, 2008. The modifications are, however, to be completed when submitting the July 2008 data.

Upon implementation of the May 1, 2008, changes, all impacted policies should be corrected to reflect the updated Edit Specifications. Please ensure that new and renewal business for elevation-rated buildings with subgrade crawlspaces, rated without the application of the CRS discount, are endorsed effective the beginning of the policy term (for policies effective on or after May 1, 2008) to include the CRS discount when the community's certification of compliance for the subgrade crawlspace is received.

If these changes generate transaction errors before WYO companies can make the necessary programming changes, the NFIP Bureau and Statistical Agent staff will work with the companies to make sure that errors related to this change will not be included in determining the number of errors that are over tolerance.

The additional TRRP Plan and Edit Specifications changes should replace or be included with those May 2008 changes previously identified in WYO Clearinghouse Bulletins W-07065 (November 8, 2007) and W-08005 (February 4, 2008).
