SUBJECT: Change in May 2020 Community Rating System Class Updates

FEMA endeavors to communicate Community Rating System (CRS) discount changes to insurers prior to the policy renewal cycle of affected policies. However, for the May 2020 CRS changes, the implementation occurred during the renewal cycle for many of the affected policies. To ensure consistency across the National Flood Insurance Program (NFIP), FEMA has decided to delay the implementation date of the May 2020 CRS changes for policyholders whose CRS discount decreased.

For NFIP policyholders whose CRS discount decreased as a result of the May 2020 CRS changes, FEMA has decided to delay the implementation date to August 1, 2020. NFIP policies with a policy effective date of July 31, 2020, and earlier that experienced a decrease in the CRS discount as a result of the May 2020 CRS updates are eligible for a refund in the difference of premium. Attached is a list of the impacted communities. FEMA requests that NFIP insurers process premium refunds for eligible policies by October 31, 2020.

FEMA apologizes for any inconvenience that this has caused to NFIP policyholders and stakeholders.
